In addition to directly assigning privileged accounts to end users, Oracle Privileged Account Manager allows you to assign privileged accounts to groups. For example, you might want to create a "Data Center Product UNIX Administrators" group and give that group access to certain privileged accounts.

When designing your deployment, it is important to ensure that a given end user is granted access to a privileged account through only one path (either directly or through a single group). When Oracle Privileged Account Manager discovers multiple grant paths, it picks the first path retrieved from its back-end, which leads to non-deterministic behavior.
