DUNS field:

Enter the Data Universal Numbering System (DUNS) number that is assigned to the selected vendor\\'s organization.

D: Set up global address book parameters [AX 2012]

Before you begin to work with the global address book or another address book in Microsoft Dynamics AX, you must set default values for your address books in the Global address book parameters form.

Select the Display DUNS number on addresses check box to display the Data Universal Numbering System (DUNS) number in a party record\\'s information. Note: Every company that does the trade in United states has a D-U-N-S number (DU-N-S Number is a unique nine-digit identification sequence, which provides a unique identifier of single business entities, while linking corporate family structures together).
