Tokenization means that all or part of data in a field is replaced with a randomly generated token. The token is stored



with the original value on a token server or token vault, separate to the production database. An authorized query or app can retrieve the original value from the vault, if necessary, so tokenization is a reversible technique. Tokenization is used as a substitute for encryption, because from a regulatory perspective an encrypted field is the same value as the original data.
