

Exchange ActiveSync is a protocol that enables client devices (smart phones, PDA\\'s, tablets, laptops) to synchronize Exchange mailbox data using HTTP over an Internet connection.

All mailbox data including emails, contacts and calendar information is synchronized to the ActiveSync enabled device. A user can compose or reply to emails and configure calendar appointments while the device is not connected to the Internet. When the ActiveSync enabled device connects to the Internet, all changes made to the mailbox data (email replies, calendar events etc.) are synchronized back to the Exchange server.

On the General options page, select or clear the check box next to the features you want to change, and then choose Save.

Note: To manage the interoperability between Teams and Skype for Business, a new policy called Teams interop policy can be utilized to control where to send chats and route calls, Teams or Skype for Business, and this policy can be

configured for all users in the organization (global policy) or applied at the per user basis, manageable through Skype for Business remote Windows PowerShell session using *-CsTeamsInteropPolicy cmdlets.

Box 1: Safe attachments policy

The ATP Safe Attachments feature checks to see if email attachments are malicious, and then takes action to protect your organization.

Box 2: Safe attachments policy

When you set up ATP Safe Attachments policies in Office 365, you can choose from several options, such as Block, Replace, and Dynamic Delivery.

The dynamic delivery option eliminates email delays by sending the body of an email message through with a placeholder for each email attachment. The placeholder remains until the attachment is scanned by ATP Safe Attachments in

Office 365. Email recipients can read and respond to their email messages right away, knowing that their attachments are being analyzed.

Box 3: Safe Link policy

ATP Safe Links in email

At a high level, here\\'s how ATP Safe Links protection works for URLs in email (hosted in Office 365, not on-premises):

People receive email messages that contain URLs.

All email goes through Exchange Online Protection, where IP and envelope filters, signature-based malware protection,

anti-spam and anti-malware filters are applied.

Email arrives in people\\'s inboxes.

A user signs in to Office 365, and goes to their email inbox.

The user opens an email message, and then clicks on a URL in the email message.

The ATP Safe Links feature immediately checks the URL before opening the website. The URL is identified as blocked, malicious, or safe

Documents shared externally must not contain personally identifiable information (PII).

Sharing for any document that contain PII must be blocked automatically.

Quarterly review meetings must be recorded and made available online for later viewing.

Users must not be able to download previous versions of Office.

Office updates must be available to users as soon as they are available.

Windows and macOS devices must have access to production-ready 2016 versions of Office applications.

Atlanta Office

You identify the following requirements to support users in the Atlanta office.

Users in the Atlanta office must not have access to any documents shared by the sales department.

External sharing must be disabled.

Users must access SharePoint Online by using the URL https://fabrikam.sharepoint.com/sites/atlanta

Sales department

You identify the following requirements to support users in the sales department:

Users in the sates department must be able to share documents externally by using guest links.

External users must not be required to sign in when visiting a guest link.



A legal disclaimer must be added to all outgoing emails.

Team members must be able to invite external users to dial into a conference by using a land-line or mobile phone.

Accounting department

The accounting department must be able to set permissions for their own sites. User accounts named User1 and Admin1 must be notified if the storage for accounting users reaches 80 percent of the 1 terabyte (TB) limit. You are unable to configure storage for the accounting department. The Site Collection ribbon for accounting department site collection is shown below.



Claims department

The claims department frequently receives emails that contain attachments. The approved list of attachment types includes:
